1. Eligibility

The MHRV Travel Trailer Giveaway (hereinafter the “**Giveaway**”) is only open to legal residents of 47 United States and the District of Columbia who are at least 18 years old at the time of entry. **Residents of the States of New York, Rhode Island, and Florida are prohibited from entering this Giveaway. Via US Mail: On a 3x5 post card, simply handprint your full name, complete address, e-mail address, and telephone number and mail the card with proper postage affixed to: M.H.R.V. Show Association P.O. Box 1528 Renton, Washington 98057 USA, Attention: Travel Trailer Giveaway Department. All mail-in entries must be postmarked on or after February 9, 2016 and received by May 6, 2018.

Limit one entry per person per event location for the duration of the Giveaway Period. Entries received from any person in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

6. Conditions of Entry

Eligible entrants must enter via one of the entry methods as described. Incomplete entries are void. Any entry by a resident of New York, Rhode Island, Florida, or Puerto Rico is void. By entering, entrants acknowledge compliance with these Official Giveaway Rules, including all eligibility requirements. The Sponsor is not

A 2017 Winnebago Drop model WD1710 Travel Trailer, made by Winnebago, with a retail value of \$23,027 (see features at <https://winnebagoind.com/products/travel-trailer/2016/winnie-drop/overview/>). Options, exterior and interior colors and fabrics will be chosen by Sponsor. Any taxes on prizes won will be the sole responsibility of the winner. No substitution or transfer of prizes permitted.
